Resolution:

BE IT RESOLVED, that the County Administrator be authorized to negotiate Agreement PW 29-45-24 with St. Bonifacius for drainage and multimodal improvements along County State Aid Highway (CSAH) 92 (Main Street) from Glacier Road to Trunk Highway (TH) 7, county project (CP) 2201100, at a county cost not to exceed \$289,000; that following review and approval by the County Attorney's Office, the Chair of the Board be authorized to sign the agreement on behalf of the county; and the Controller be authorized to disburse funds as directed.

Background:

The Cost Participation and Partnerships (CP 2201100) program provides funding for partnership projects that advance city and county aligned transportation goals. The City of St. Bonifacius, in collaboration with the county, is leading a project along Main Street from Glacier Road to TH 7, which has experienced recurring flooding especially during winter months as ice accumulates, causing safety concerns for people traveling through the area. The project, scheduled to begin construction in fall 2024, includes reconstruction of roadway, curb and gutter, a multi-use trail, and stormwater infrastructure to improve drainage along the corridor. The agreement identifies the city to lead the project delivery. After completion, the city will own and maintain the improvements at no county cost.

Funding for the county's cost participation is available in CP 2201100 Cost Participation and Partnerships 2024-2028 and expenses tracked in its associated sub-project CP 2201107 - 2023 CPP - St. Boni CSAH 92.

Current Request:

This request seeks authorization to negotiate and execute Agreement PW 29-45-24 with St. Bonifacius for drainage and multimodal improvements along Main Street, CP 2201100, at a county cost NTE \$289,000; with expenses tracked under CP 2201107.

Impacts/Outcomes:

These improvements will support the county's Mobility 2040 goals, climate action and disparity reduction efforts by improving accessibility, mobility, and safety for multimodal transportation.

BE IT RESOLVED, that the Agreement PR00006467 with Anoka, Carver, Dakota, Ramsey, Scott and Washington counties to allow the reciprocal use of household hazardous waste management facilities and to provide for payment of costs incurred by the counties receiving household hazardous waste during the period January 1, 2025 through December 31, 2029, be approved; that the Chair of the Board be authorized to sign the agreement on behalf of the county; and that the Controller be authorized to accept and disburse funds as directed.

Background:

Hennepin County provides Household Hazardous Waste (HHW) service at two drop-off facilities and seasonal collection events. HHW includes household quantities of:

- Automotive fluids: Antifreeze, carburetor cleaner, brake and transmission fluid, degreasers, fuels and oil
- Electronics: Audio and video equipment, cameras, cell phones, DVD players, computers, game systems, mobile devices, printers, telephones, TVs, radio and music players, rechargeable products and vape pens
- Household, lawn and garden products: Batteries, cleaning products, drain cleaner, fluorescent light bulbs, lighter fluid, mercury thermostats, oven cleaner, paints, stains and thinners, pesticides and herbicides
- Personal care products: Hair spray, mercury thermometers, nail polish remover, perfume and syringes

By properly collecting and managing these materials, Hennepin County is protecting human health and the environment.

To provide easier access to HHW services, the counties of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington have allowed residents to deliver these materials to any of the HHW management facilities within the region.

Each year over 2,500 residents from Hennepin County use HHW management facilities in other counties at an average cost of \$90,000 per year. In turn, each year over 1,200 participants from other counties used Hennepin County's HHW management facilities for which Hennepin County has received an average of \$45,000 per year. The current reciprocal use agreement will expire December 31, 2024.

Current Request:

This request is for approval of Agreement PR00006467 among the counties of Hennepin, Anoka, Carver, Dakota, Ramsey, Scott and Washington for reciprocal use of HHW management facilities.

The agreement will provide for the payment of a regional per vehicle fee based on the average cost per

vehicle amongst all the counties. The regional per vehicle fee simplifies administrative procedures and recognizes the value of providing convenient HHW services to residents throughout the region.

Impacts/Outcomes:

Approval of Agreement PR00006467 will allow residents of Anoka, Carver, Dakota, Hennepin, Ramsey, Scott and Washington counties to deliver HHW to any HHW management facility within the region, for the period January 1, 2025 through December 31, 2029.

The agreement will also satisfy Strategy 62 of the Minnesota Pollution Control Agency's Metro Solid Waste Policy Plan for 2022-2042 which states to continue participation in the reciprocal use agreement for HHW collection sites.

- Agreement PR00006420 with 700 American Blvd LLLP or affiliated entity, in an amount not to exceed \$162,685.
- Agreement PR00006422 with the City of Minneapolis, in an amount not to exceed \$137,250,
- Agreement PR00006421 with the City of Minneapolis, in an amount not to exceed \$129,970, and
- Agreement PR00006423 with Minnesota Brownfields, in an amount not to exceed \$400,000; and

BE IT FURTHER RESOLVED, that following review and approval by the County Attorney's Office, the County Administrator be authorized to sign the agreements on behalf of the county; that costs incurred by the grantees after the board approval date be eligible for reimbursement upon execution of the agreements; that the County Administrator be authorized to approve extensions of a 12-month period to the agreements; and that the Controller be authorized to disburse funds as directed.

Background:

The Environmental Response Fund (ERF) helps revitalize sites by providing funds to assess and clean up contamination. The grants reduce barriers to site improvement or redevelopment caused by the added costs of environmental cleanup and lessen the risk to human health and the environment posed by the contamination.

Minnesota Statutes, sections 383B.80 and 383B.81, authorize the county to collect a mortgage registry and deed tax for the purpose of establishing an environmental response fund. The board established the ERF in 1997 (Resolution 97-06-410R1) and authorized the grant program in 2001 (Resolution 01-615).

Since 2001, ERF has funded 492 projects totaling more than \$77.5 million. Projects supported by ERF provide a variety of community benefits, including creating affordable and moderately priced housing, supporting economic development, and making infrastructure improvements. Many ERF grants address environmental contamination in communities with significant disparities in health, including low-income areas and communities of color. Some of these sites become catalysts for new development in neighboring areas, which can help address racial disparities in housing, employment, and income.

In March 2024, the county solicited proposals from municipalities and nonprofit and for-profit developers, receiving five applications. Applications were evaluated on project need, the risk posed by the contamination and the appropriateness of the cleanup approach, creation or preservation of affordable and/or moderately

priced market-rate housing, the fostering of economic development, and the readiness of the project to proceed. To maximize collaboration between funders, the timing of the ERF grant round coincides with additional contamination cleanup grant programs administered by the Minnesota Department of Employment and Economic Development and the Metropolitan Council. Four applications were recommended for award.

As a major economic center for 150 years, the county has a concentration of contaminated sites. Much of this contamination was caused by chemical spills or improper disposal of hazardous waste prior to the existence of environmental regulations. These improper disposal practices of the past can still cause soil and groundwater pollution that present environmental risks today. In addition, many buildings in Hennepin County, particularly in Minneapolis and the inner ring suburbs, were constructed prior to 1970 when the use of asbestos and lead-based paint was prevalent.

Current Request:

This request is to authorize the County Administrator to negotiate ERF grant agreements during various periods, with the total combined amount not to exceed \$829,905.

The four Spring 2024 ERF requests recommended for funding are summarized as follows and are described in the attached report, Environmental Response Fund Spring 2024 Funding Recommendations.

- American Boulevard Senior Living, Bloomington \$162,685 for vapor mitigation costs associated
 with the development of a five-story apartment complex with 128 affordable housing units, including
 eight project-based vouchers, and 1,500 square feet of commercial space. (Grantee: 700 American
 LLLP)
- Native American Community Clinic and Housing, Minneapolis \$137,250 for soil cleanup and vapor mitigation costs associated with the redevelopment of 83 affordable housing units and a new expanded clinic building. (Grantee: City of Minneapolis on behalf of NACC and Wellington Management)
- Passage Community Housing, Minneapolis \$129,970 for soil vapor mitigation and lead sampling
 and abatement costs associated with the rehabilitation of a three-story building with approximately 17
 supportive housing units. (Grantee: City of Minneapolis on behalf of Simpson Housing Services, Inc.)
- Minnesota Brownfields Gap Financing Program, countywide \$400,000 to continue the Brownfields Gap Financing Program, which provides small environmental grants to government entities and non-profit organizations. New this year, this program expands to include emerging developers and increases per project costs. (Grantee: Minnesota Brownfields)

This request also seeks approval for the county administrator to sign the agreements; allows the grantees to incur costs after the board approval date, with reimbursements being paid upon execution of the grant agreements; and authorizes the county administrator to approve extensions of a 12-month period to the grant agreements.

Impact/Outcomes:

The recommended ERF grant awards will fund soil cleanup, vapor mitigation, asbestos and lead abatement, and pre-development assessments. The awards will also assist developments that increase the tax base, create permanent jobs, and create affordable and moderately priced market-rate housing. The recommended grants support the renovation or construction of 228 affordable housing units.

ERF grants reduce environmental contamination and support projects in communities with disparities in health, housing, employment, and income. Many of the projects supported by these grants include the construction or renovation of buildings that incorporate sustainable features, which support the county's climate action goals.

Overview

Background

The Environmental Response Fund (ERF) helps revitalize properties by providing funding to assess and clean up contamination. This helps recipients overcome barriers that the cost of environmental cleanup pose to site improvement or redevelopment. Cleaning up these sites also reduces the risk to human health and the environment.

ERF grants are used for a variety of activities that provide community benefit, including:

- · Assessment and cleanup of soil and groundwater
- Evaluation and abatement of asbestos and lead-based paint
- Protecting buildings and occupants from contaminated soil gas vapor building intrusion

Since 2001, ERF has funded 492 projects totaling \$77,595,832. Funding for the ERF grant program comes from the Hennepin County mortgage registry and deed tax that was authorized in 1997 under Minnesota Statutes, section 383B.80. The board established the ERF in 1997 (Resolution 97-06-410R1) and authorized the grant program in 2001 (Resolution 01-615).

Applications and review process

A committee of six staff from Hennepin County's Environment and Energy, Housing and Economic Development, and Land Information and Tax Services reviewed the applications and made recommendations for funding. Applications were evaluated on project need, the risk posed by the contamination and the appropriateness of the cleanup approach, creation or preservation of affordable and/or moderately priced market-rate housing, the fostering of economic development, and the readiness of the project to proceed.

The timing of the ERF grant round coincides with contamination cleanup grant programs administered by the Minnesota Department of Employment and Economic Development (DEED) and the Metropolitan Council to maximize collaboration among the three funders.

Summary of award recommendations

Five applications were received and reviewed. The committee recommends awarding four grants totaling \$829,905. Details on funding recommendations for each project are provided in the individual application summaries that follow.

- American Boulevard Senior Living, Bloomington \$162,685 for vapor mitigation costs associated with the development of a five-story apartment complex with 128 affordable housing units, including eight project-based vouchers, and 1,500 square feet of commercial space (Grantee: 700 American LLLP) Recommended Award: \$162,685
- Native American Community Clinic and Housing, Minneapolis \$174,750 for soil cleanup and vapor mitigation costs associated with the redevelopment of 83

- affordable housing units and a new expanded clinic building. (Grantee: City of Minneapolis on behalf of NACC and Wellington Management) Recommended Award: \$137,250
- Passage Community Housing, Minneapolis \$129,970 for soil vapor mitigation and sampling and lead abatement costs associated with the rehabilitation of a three-story building with approximately 17 supportive housing units. (Grantee: City of Minneapolis on behalf of Simpson Housing Services, Inc.) Recommended Award: \$129,970
- Ole Olson Park, Minneapolis —\$542,150 for soil cleanup costs associated with the trail, riverbank, and landscape renovation at Ole Olson Park. (Grantee: Minneapolis Park and Recreation Board) Recommended Award: \$0
- Minnesota Brownfields Gap Financing Program, countywide \$400,000 to continue the Brownfields Gap Financing Program, which provides small environmental grants to government entities and non-profit organizations. New this year, this program expands to include emerging developers and increases per project costs. (Grantee: Minnesota Brownfields) Recommended award: \$400,000

The recommended ERF grant awards will fund soil cleanup, vapor mitigation and sampling, abatement activities, and assessment. The awards will also assist developments that increase the tax base, create or retain permanent jobs, and create and retain affordable housing. The recommended grants provide for the renovation or construction of 228 affordable housing units, including 17 supportive housing units. Affordable housing units include single-family, multi-family, senior, and temporary/supportive occupants. ERF grants reduce environmental contamination and support projects in communities with disparities in health, housing, employment, and income.

Additional funding mechanisms

In addition to the ERF, Hennepin County offers several other funding mechanisms for brownfields assessment and cleanup. Through grants from the U.S. Environmental Protection Agency (EPA), Hennepin County has low-interest loans available for brownfields cleanup in the Revolving Loan Fund (RLF) Program. Hennepin County also provides funding for brownfields environmental assessments to cities and nonprofit organizations on a rolling basis. This assessment funding comes from the county's RLF loan repayment proceeds and the Minnesota Brownfields Gap Financing Program (funded through an ERF grant). These flexible funding sources have helped many organizations develop the environmental assessment information needed to submit applications to the ERF, DEED, and the Metropolitan Council for cleanup funding. Two of the ERF Spring 2024 applicants have received assessment funding from one or more these other county funding sources.



Program description

The county established the Brownfields Gap Financing (BGF) Program in 2007 to provide timely funding for local units of government and non-profit organizations to address smaller-scope environmental issues for projects with limited budgets. Minnesota Brownfields, a non-profit organization, has administered the program since 2013. Projects requesting assistance from the program submit applications on a rolling basis and are evaluated by Minnesota Brownfields and county staff. This grant round, two projects were also assisted by BGF Program grants: Native American Community Clinic and Housing and Passage Community Housing.

The current funding request reflects several proposed changes to the program. For over a decade, program policy has directed a maximum assistance amount per project of \$15,000 annually. The current funding request would allow an increase of this maximum amount to \$25,000, which is consistent with Ramsey County's BGF Program and reflects the current services rates for typical environmental work funded with this program. The other program change reflected in this funding request is expanding the list of eligible applicants to include for-profit emerging developers, which is consistent with Ramsey County's BFG Program and reflective of Hennepin County goals on supporting historically marginalized groups with overcoming financial barriers. ERF staff intends market this program to emerging developers, including those emerging developer recipients of funding from Hennepin County's Transit Oriented Communities (TOC) Predevelopment Assistance Program. ERF staff will partner with TOC staff to help TOC Predevelopment Assistance recipients

with pursuing environmental assistance on their project sites through the BGF Program. This connection between programs across county departments will help provide a more complete service and assistance package to emerging developers operating in Hennepin County.

Contamination issues: To be determined.

Program Accomplishments: As of June 2024, Minnesota Brownfields has committed 84% of the funds from the last grant award of \$300,000 in Fall 2022. Full expenditure of remaining funds is expected before the contract associated with this request would be executed. Between 2013 and 2024, 107 affordable housing projects, 22 school and community garden projects, 25 neighborhood revitalization projects, 11 projects related to arts and culture, and 21 projects related to youth, family and health services have benefited from the Brownfield Gap Financing Program.

Requested use of ERF grant: Funding for environmental assessment to support the continuation of the Brownfield Gap Financing Program.

Background:

The Hennepin County Board of Commissioners authorized Master Funding Agreement A142418 with the Metropolitan Council as an umbrella agreement to provide for activities performed by the county in connection with and in support of the METRO Green Line Extension (Southwest) Light Rail Transit Project (Resolution 14-0515). The Master Funding Agreement requires negotiation and execution of subordinate funding agreements for all county project activities.

Pursuant to that Master Funding Agreement, the board subsequently authorized a series of Subordinate Funding Agreements with the Metropolitan Council, each of which reimburses the county for dedicated staff costs for construction inspection and other related tasks for the METRO Green Line Extension project in a given year:

- Agreement A199488 for fiscal year 2019, receivable of \$783,028 (Resolution 19-0061),
- Agreement A1910056 for fiscal year 2020, receivable of \$399,101 (Resolution 20-0022),
- Agreement A2010388 for fiscal year 2021, receivable of \$410,652 (Resolution 20-0455),
- Agreement A2111083 for fiscal year 2022, receivable of \$417,352 (Resolution 22-0014),
- Agreement A2211487 for fiscal year 2023, receivable of \$423,007 (Resolution 22-0492), and
- Agreement A2311981 for fiscal year 2024, receivable of \$172,000 (Resolution 23-0461).

Under Agreement A2311981, County staff provide services related to construction inspection, surveying, and oversight of the Project. The Metropolitan Council reimburses the county for these professional staff costs, based on actual payroll records and in accordance with the positions authorized. Staff costs are reimbursed at each employee's actual rate of pay, plus usual and customary labor overhead additives and equipment fees, per Exhibit A of the Agreement.

This board action request would authorize negotiation and execution of Amendment 1 to Agreement A2311981 to increase by \$61,012 the reimbursement amount to the county for dedicated staff costs incurred for the project, for a new total estimated receivable amount of \$233,012. The end date and all other terms of the

Background:

As part of the METRO Green Line Extension Project, the Metropolitan Council allowed local governments to identify local projects for design, environmental clearance, and construction by the Southwest Light Rail Transit project office. Funding for local projects is provided by the local unit(s) of government and administered by Metropolitan Council under Master Funding Agreement A142418 (Resolution 14-0515) and individual Subordinate Funding Agreements (SFAs) for identified local projects.

This Resolution relates to two SFAs that Hennepin County entered into with the Metropolitan Council: Agreement: A166373 for Environmental Response Fund eligible assessment and cleanup of contaminated sites and Agreement A166577 for installation of fiber optic infrastructure and construction of a trail along County State Aid Highway 61. The Board authorized Agreement A166373 through Resolution 16-0429 on November 15, 2016, and Agreement A166577 through Resolution 17-0016 on January 24, 2017.

On August 27, 2019, the Board adopted Resolution 19-0334, authorizing amendments to these two agreements and two other SFAs related to the Project. These amendments incorporated revised payment terms and extended the contract end dates. Amendment 1 to Agreement A166373 extended the contract end date to December 31, 2023. Amendment 1 to Agreement A166577 extended the contract end date to December 31, 2024.

On June 1, 2021, the Board adopted Resolution 21-0185, authorizing Amendment 2 to Contract A166373 to permit assessment and cleanup of additional contaminated sites related to the Project and reimbursement of cleanup-related costs by the Environmental Response Fund, without any change in the contract end date or the maximum contract amount.

Background:

The Green Partners grant program provides support and funding to organizations to implement projects that engage residents to protect and improve the environment. Since the program was established in 2012, the county has awarded 259 grants totaling more than \$3.5 million. Funding for the program comes from the Solid Waste Enterprise Fund.

The program offers three types of grants: Youth Environmental Education grants for projects engaging young people in environmental education and stewardship, a grant program for Youth Green Jobs, and Environmental Action grants for projects that focus on motivating adults to take environmentally friendly actions.

Eligible organizations include:

- registered nonprofit organizations such as community groups, youth organizations, and congregations;
- park districts; and
- private and public schools, including community education programs such as early childhood family education.

The county released a request for proposals in March 2024. A total of 61 applications were received. Of the 33 Youth Environmental Education grant applications received, 17 are recommended for funding. Of the 12 Youth Green Jobs applications received, four are recommended for funding. Of the 16 Environmental Action grant applications received, six are recommended for funding. A total of 27 grants are recommended, for a grand total amount of \$777,900.

Impact/Outcomes: The Green Partners projects support the county's goals of promoting environmental stewardship, engaging communities, enhancing quality of life, and protecting the environment for current and future generations.

Five of the applicants are first-time grantees with the Green Partners program. Of the 27 projects, 26 projects focus on engaging audiences that face disparities.

Organizations listed in this request will engage more than 9,400 people, including more than 8,100 youth, in becoming environmental stewards and taking action to protect the environment. More than 70 youth will be hired for green jobs exploration and training. These projects are expected to reach more than 116,000 people with environmental messages.

Hennepin County prioritizes environmental education and engagement with audiences that experience

disparities and those audiences that contribute most to environmental problems that result in disparities. The Green Partners program also helps meet the county's goals outlined in the Climate Action Plan by engaging with the public and supporting community driven solutions.

Organizations are required to report project outcomes. Research has shown that these models of environmental engagement are effective in motivating participants to take actions that have a positive impact on the environment.

Recommendation from County Administrator: Recommend Approval
