- PR00005343 with City of Bloomington, not to exceed \$82,500
- PR00005344 with City of Eden Prairie, not to exceed \$80,500
- PR00005345 with City of St. Louis Park, not to exceed \$82,500
- PR00005346 with City of Maple Grove, not to exceed \$37,500

BE IT FURTHER RESOLVED, pursuant to Minnesota Statute § 473.757, subd. 2, the Hennepin County Board of Commissioners re-authorizes the award of available ballpark sales tax dollars to fund youth activities and youth sports through the Hennepin County Youth Activities Grants program; and

BE IT FURTHER RESOLVED, that following review and approval by the County Attorney's Office, the Purchasing Director be authorized to sign all agreements awarded funds pursuant to Hennepin County Youth Activities Grants; and that the Controller be authorized to disburse funds as directed; and

BE IT FURTHER RESOLVED, that the Purchasing Director be authorized to approve amendments to agreements awarded funds pursuant to Hennepin County Youth Activities Grants in order to extend their term.
